We know legalism (salvation by law keeping) and antinomianism (salvation without the need for law keeping) are both wrong, but antinomianism feels like a much safer danger." — Kevin DeYoung

"The details and particular ingredients of which holiness is composed in daily life, ought to be fully set forth and pressed on believers by all who profess to handle the subject. True holiness does not consist merely of believing and feeling, but of doing and bearing, and a practical exhibition of active and passive grace. Our tongues, our tempers, our natural passions and inclinations—our conduct as parents and children, masters and servants, husbands and wives, rulers and subjects—our dress, our employment of time, our behaviour in business, our demeanour in sickness and health, in riches and in poverty—all, all these are matters which are fully treated by inspired writers. They are not content with a general statement of what we should believer and feel, and how we are to have the roots of holiness planted in our hearts. They dig down lower. They go into particulars. They specify minutely what a holy man ought to do and be in his own family, and by his own fireside, if he abides in Christ. I doubt whether this sort of teaching is sufficiently attended to in the movement of the present day." 4— J. C. Ryle
